

Styrelsens redogörelse enligt 13 kap. 6 § aktiebolagslagen (2005:551)

Statement by the Board of Directors pursuant to Chapter 13, section 6 of the Swedish Companies Act (SFS 2005:551)

Styrelsen i Scandinavian Real Heart AB, org.nr 556729-5588 ("Bolaget"), avger härmed följande redogörelse enligt 13 kap. 6 § aktiebolagslagen (2005:551) med anledning av förestående beslut om nyemission av units bestående av aktier och teckningsoptioner med företrädesrätt för aktieägarna, vid styrelsemöte omkring den 7 maj 2024.

The Board of Directors of Scandinavian Real Heart AB, Reg. No. 556729-5588 (the "Company"), hereby submits the following statement pursuant to Chapter 13, section 6 of the Swedish Companies Act (SFS 2005:551) regarding the forthcoming board meeting on or about 7 May 2024, to resolve on new issue of units consisting of shares and warrants with preferential rights for the shareholders.

Efter avgivande av Bolagets årsredovisning för räkenskapsåret 2022 har det inte inträffat någon händelse som är av väsentlig betydelse för bolagets ställning, utöver vad som framgår av (i) den bokslutskommuniké som Bolaget har offentliggjort avseende perioden 1 januari – 31 december 2023, (ii) pressmeddelande av den 11 mars 2024 med rubrik "Magnus Öhman tillträder som arbetande ordförande i Realhearts styrelse", och (iii) pressmeddelande av den 15 april 2024 med rubrik "Realheart rapporterar resultat från ytterligare ett framgångsrikt prekliniskt försök med det artificiella hjärtat Realheart® TAH".

Since the presentation of the Company's annual report for the financial year 2022, no events of material significance for the Company's financial position have occurred, other than disclosed (i) in the year-end report the Company released for the period 1 January – 31 December 2023, (ii) press release from the 11 March 2024 with the heading "Magnus Öhman Appointed Executive Chairman at Realheart", and (iii) press release from the 15 April 2024 with the heading "Realheart Reports Results From Another Successful Preclinical Trial With the Artificial Heart Realheart® TAH".
